



Memorandum of Understanding

Between

Eurasian International Medical University Bishkek, Kyrgyzstan and RUPA Trading HousePvt-Ltd.

This Memorandum of Understanding is made on Friday, May 21st -2021 between the Eurasian International Medical University, Bishkek, Kyrgyzstan referred as EIMU and the RUPA Trading HousePvt-Ltd referred as "RTH".

WHEREAS, EIMU is an institution of higher learning in health sciences. It is recognized by World Health Organization and the Ministry of Education & Science of the Kyrgyz Republic. It offers 5 years courses in Doctor of Medicine in English language (MD).

WHEREAS RUPA Trading HousePvt-Ltd known as RTH is a private limited company,, registered under Companies Act of Pakistan 2017 (XIX of 2017). It is dedicated to promoting education, training and scholarship in emerging fields of sciences and humanities in pursuit of peace and harmony among cultures, societies and nations.

AND WHEREAS the objective of this Memorandum of Understanding is to create conditions for cooperation between the Parties in the field of education, training, research and allied subjects.

NOW THEREFORE this Memorandum of Understanding witnesses as follows:

- 1. The two Parties undertake to work together and carryout the following academic activities:
 - Joint education and training programs.
 - b. Arrange admission for the Autumn (October) and Spring (February) Intake for the Pakistani applicants and students for migration from the other Universities to EIMU.
 - c. Joint research projects and publications, including work by undergraduate, graduate, and Doctoral students.
 - d. Joint conferences, seminars, and workshops.
 - e. Team taught courses, including online courses.



- f. Any other form of activity that may be jointly decided upon by the Parties.
- 2. The education programs to be carried out under this Memorandum of Understanding shall include, but not be limited to, the following:
 - a. Doctor of Medicine (MD).
 - b. Any other program or service related to the teaching, training, consultancy including distant learning and online courses.
- 3. To achieve this noble objective, **Eurasian International Medical University** and **RUPA Trading HousePvt-Ltd** undertake to cooperate in the following manner:
 - a. The Eurasian International Medical University will award the following to the RUPA Trading HousePvt-Ltd:
 - i. The rights to start intake of applicants in Pakistan.
 - ii. The rights to launch the programs referred to at para two above in Pakistan.
 - iii. The rights to award degree (s) as per the terms and conditions as agreed upon by the Parties
 - iv. The curriculums, syllabuses, teaching materials and allied resources and services, as required.
 - v. Advice, guidance, assistance, and any and all other forms of services as necessary to realize the aims and objectives of this Memorandum of Understanding.
 - b. Both the Parties will share the income accrued from the intake of applicants to be agreed separately.
- 4. The following principles shall guide the Parties in the execution of this MOU:
 - a. Close co-operation in developing and execution of the programs while respecting each party's mandate, roles and responsibilities.
 - b. Optimal sharing of knowledge, expertise, and resources for the benefit of both parties and for the realization of the objective of this agreement.
- 5. In case of any ambiguity and dispute, the matter shall be resolved with mutual consent and in the event of its non-resolution, referred to the arbitrator as per prevalent laws of Kyrgyzstan (place of implementing of the agreement), who shall decide the dispute according to the provisions of the prevalent Arbitration Act.
- 6. Financial arrangements and stipulations under this agreement will be subjected to individual agreements on a case-by-case basis and are to be specifically described in detail in separate addenda.
- 7. The EIMU recognize mutual credit transfers as per policy and rules of the regulatory institutions of both countries.
- Modifications and amendments to this agreement can be made by mutual consent.

- 9. Should either institution wishes to terminate this agreement, a written notice shall be required to be given three (5) months in advance of the desired termination date.
- 10. This Memorandum of Understanding will enter into effect from the date duly signed by the designated officials of the respective institutions.
- 11. It will remain effective for One (1) year, and will stand extended for another period as long as neither party expresses a desire to terminate or modify this Memorandum of Understanding.
